### The rules:

- Deer must be shot by an employee or volunteer of the credit union or their spouse/significant other. (One deer maximum per person).
- Deer must be shot by the person registering the deer and must be a **whitetail** deer. No party registrations.
- The highest number of total antler points for the top five deer will determine the winner. (i.e. Five 8-point deer = 40 points).
- A point must be at minimum 1 inch to be eligible.
- A picture of the rack must be taken to verify the counts.
- Deer may be taken by archery, rifle, or muzzleloader thru December 31, 2011. (Vehicles are not an acceptable method.)
- In case of a tie; four deer will be counted, then three, then two, then one. After that it will be a tie.

### The wager:

- First place Credit Union receives a traveling trophy and makes a \$200 donation to Children's Miracle Network in the name of all participating credit unions.
- Second place team makes a \$300 donation to Children's Miracle Network in the name of all participating credit unions.
- Third place and remaining teams make a \$400 donation to Children's Miracle Network in the name of all participating credit unions.
